**NOTICE OF HEARING**

Please take notice that the Chancery Court of Jackson County will conduct a hearing for the following purpose:

(1) To receive information on the record from the Special Fiduciary, the Chancery Clerk, and counsel for the Jackson County Board of Supervisors, about the terms of the sale of Singing River Hospital System (“SRHS”) to the Franciscan Missionaries of Our Lady Health System (“FMOLHS”); more particularly, on the impact the sale of SRHS to FMOLHS would have on the SRHS Employees’ Retirement Plan and Trust (the “Plan”). And—

(2) To provide the opportunity for the Court (and with the Court’s permission, all affected individuals) to ask questions; and, if the Court deems appropriate, to enter an order acknowledging the sale and the Court’s exercise of continuing authority and exclusive jurisdiction over the Plan after closing, and granting any other relief the Court deems just and proper.

The hearing will take place before Hon. James D. Bell, Special Chancery Court Judge, on September 5, 2023, at 11 a.m., at the Jackson County Courthouse, 3104 South Magnolia Street, Pascagoula, Mississippi.
